This agreement is made and entered into on _____ (date), between Karena Cymbaluk, hereinafter designated as Stallion Owner, and, _____ hereinafter designated as Mare Owner.

This contract is subject to availability of each stallion's book.

Breeding Privileges:

Mare Owner hereby agrees to breed "the mare" _____, Reg. No. _____ to the stallion **PASS THE LEGACY ON**, AQHA# 5225786 & APHA# 980671 in 2015 breeding season. A STALLION SERVICE FEE OF \$500.00, Plus \$100 BOOKING FEE AND IS NON REFUNDABLE. A check for \$100 must accompany this contract along with a copy of the mare's registration papers and be returned to the Stallion Owner in order to secure a your mare's reservation in his 2015 book. The booking fee applies to all breedings, including services donated to futurities.

Breeding fees, Shipped Semen fees, mare care, vet and farrier bills must be paid in full before the mare leaves Wind Swept Acres, or prior to issuing breeding certificate from AQHA or APHA, etc. Stud fees are due when the mare is dropped off at Wind Swept Acres, all other 'On Farm' expenses are due prior to her departure. If Shipped Semen is chosen, please see Shipped Semen Attachment for additional stipulations and terms. All fees must be paid prior to the first shipment.

NO BREEDING CERTIFICATES WILL BE ISSUED UNTIL ALL INCURRED EXPENCES ARE PAID IN FULL.

Live Foal Guarantee: In the event the said breeding does not result in a foal that survives 48 hours. The said mare shall be rebred to **Pass The Legacy On**, the following year. The mare owner may substitute a mare of similar quality if prior written consent has been provided by the stallion owner. The mare owner will be responsible for the mare care, vet, and farrier expenses as well as renewed booking fee to renew the breeding contract. This guarantee is dependent upon the following conditions.

1. The mare must be properly vaccinated and wormed. (5, 7, 9 month Rhino vaccinations, etc)
2. A written confirmation of pregnancy by a licensed veterinarian is provided within 45 days of the last breeding.
3. Mares foaling before May 1st, must be foaled in a barn with conditions conducive to the well being of the foal.
4. A veterinarian issued death certificate stating cause of death within 14-days of death.

Color Guarantee: Pass The Legacy On is approved/enrolled to breed AQHA, APHA & ApHC mares. In the event that a **Color Breed Registered Mare** fails to produce a colored foal that same mare shall be rebred for only the renewed booking fee, mare care, and other incurred expenses. Qualifying color breeds include, but are not limited to: APHA, PthA, PHBA, IBHA, ABRA, ApHC and POA. Please ask if your mare qualifies.

Liability: Neither party (Mare or Stallion Owner) or anyone affiliated with either party shall be held responsible for the death, injury, or damage to person, horse, or property. All mares must have a current negative coggins test (within the current calendar year) prior to arrival at Wind Swept Acres. **NO EXCEPTIONS!**

Miscellaneous: Should the stallion die or become unfit for breeding, Mare Owner's sole recourse will be for the breeding fee, minus the booking fee. This contract is non-transferable without prior written consent. This contract is entered into in the State of Minnesota, and will be interpreted and enforced under the laws of that state.

This contract represents the entire agreement between the parties. No other agreements, promises, verbal or implied, are included unless specifically stated in this written Contract. The original contract will be kept on file at Wind Swept Acres and a copy provided for Mare Owner.

Outside provisions include fresh clean water, (choice) grass or alfalfa hay, oats, and mineral; in a paddock.

Indoor provisions include fresh clean water, (choice) grass or alfalfa hay, oats, and mineral; in a 12 x 12 or larger stall with daily exercise, weather permitting.

Dry (Mare Only) \$15.00

Wet (w/ foal at side) \$18.00

Reduced rates can be arranged if you are breeding two or more mares at the same time. Discounts are on a case by case basis and subject to fluctuations in feed cost.
